We certainly are most heartily in favor of everything the convention stands for, and we certainly wish Mr. Lord the greatest of success in making this convention possible.

We have the following FCC information for the members of our club this week. WBRX, New Orleans, La. has been granted extension of special authority to remain silent from November 4th to Nov. 15th. KSTP, St. Paul, Minn. has been granted permission to carry on synchronization experiments with station WJSV, Alexandria, Va. WCOD has been granted a change in call letters to WKRC. They are not operating in the Penn-Harris Hotel in Harrisburg instead of the Governor Hotel. WHRT, Troy, Ala. has been granted a construction permit to move station from Troy to Dothan, Ala; studio in Houston Hotel, and change frequency from 1210 to 1370 kycs.

Our CPC are busily engaged just now in working on our big Frolic on December 16th and 17. We hope to be able to report progress on this party by the time the next tipsheets come to you.

Don't forget that the morning of November 18th will afford all of you an opportunity to try for a Real South American station. This is station CX26, Montevideo, Uruguay. There are quite a few of the boys that have already heard this station and they advise us that they come in fairly strong, so we hope that all of you will be fortunate enough to bring in this station.

We have just recently begun to exchange Bulletins with the Shrewsbury Radio Club and the New England Radio Club. Incidentally the Shrewsbury Radio Club advise us that in the near future they are changing the name of their club to the American Radio Club. We are now receiving tips from the following clubs: Canadian DX Club; Central DX Club; Globe Circlers DX Club; Newark News Radio Club; Transcontinental Radio Club; Shrewsbury Radio Club; International DXers Alliance and the New England Radio Club.
