WJHL-Expect to start regular Schedule by November 15th.. WDAN expects to start regular scdedule October 16 and will test from October 10 to 16 from 2:00 AM EST an they use 1500 kc 250 watts. WKAR have permission to use a 100 watt xmitter on 850 kc from 1-6 AM from Sept 20 to October 19 to determine antenna location.

Greetings owl...here 'tis...the first week in October and the first weekly column for you NNCers. We hope that our efforts will cause you to chuckle and grin a bit, and to DX a bit, and that in turn you will help us with our next issue by sending in your reports on your DX doing.

Radio have been playing an important part in world developements again. During the past several weeks we have heard stations on the early morning hours with election results, flood and tornado news, and war bulletins. The alert DXer will do well to keep these things in mind and watch for specials events. A great many stations have been heard in the past two weeks that are seldom on the air. The Columbia Broadcasting System has been making use of the wee small hours and quite a few CBS stations have been staying on extra hours.

The European situation has had no effects on the FCC as far as dishing out construction permits is concered. The parade of new grants continues as the following cities get new stations. Troy N.Y.: Gastonia N.C. Columbia S.C.: Charleston S.C.: Vernon Texas: Petersburg Va. Details on

the front page.

Other important decisions handed down by the FCC include a change of frequency for WELI, New Haven Conn. They will switch from 900 to 930 kcs, and will operate unlimited hours with 500 watts day and 250 watts night. -

WBNO, New Orleans La. who have been sharing time with WJBW on 1420 kcs. will shift to 1420 kcs and operate unlimited hours with 250 watts days and 100 watts night. This decision settles a lenthy controversy.

KCMO, Kansas City Mo. have been handed a choice morsel by the FCC. They will switch from a smally on 1370 to 1450 kcs, on which frequency they will use 1000 watts unlimited hours.

The Fifth Avenue Broadcasting Corp announce the wedding of their daughter WFAR to the Debs Memorial Radio Fund, Inc. The ceremony was performed by the Federal Communications Commission and henceforth these two New York City transmitters will be identified with the singular call of WEVD. So, boys and girls, delete Miss WFAF from your logs. WEVB will use the 36 hours per week that were formerly used by WFAB but will continue to share time with WHAZ, Troy WBBR Brooklyn.

The new Indianapolis station WIBC, started operations on Sept.25th Their studios are located on the ninth floor of the Indianapolis Athletic Club. They will operate from 6 A.M. (7 EST) untill local sunset on 1050 kcs., with 1000 watts. It is interesting to note they are using the old transmitter of WIRE.

We are informed that the Salisbury N.C station, WSTP, will have studios located in the Yadkin hotel in that city. They will use 1500 kcs with the usal 100/250 watts power. Their call letters mean We Serve The Piedmont.

- 1. This contest will begin October 15 1938 and end April 15 1939.
 2. Only those verifications whick have been received since the beginning of this year (1938) are eligible for this contest. We shall goven ourself according to the DATE the verification was issued. This is being done to eliminate the possibility of verifications which may be four or five years old from entering this contest.
- 3. This contest will be in charge of "Pat Reilly" 810 North Main St., Jamestown New York. The Board of Directors will be the permanent Judges and all decisions made by these gentleman will be regarded as final. 4. Each member in good standing, is eligible to enter this contest. Suppose for example, John Doe receives a verification from KATE, Alberta Lea Minn., Mr. Doe refers to the possible Singleton list and find KATE, is listed there. Hence Mr. Doe sends in his verification from this station and provided that it is the first entry from that station, Mr. Doe is accordingly acredited with a singleton. It will not be necessary to send the actual verification in, your word will be your bond, and verification will only be required where it seems reasonble to dought anyone's Claim. 5. Suppose that John Henry also receives a verification from KATE, he in turn consults the contest Reports, and finds it listed under the Possible Singleton, and notifies us accordingly. Since Mr. Doe holds the first verification from this station, which has been received by a member of the club, he naturally holds the Singleton, but the Eliminator. It may be that some one may hold a Singleton for four or five months befor it is finally eliminated, or they may hold it as a Singleton for the entire duration of the Contest.
- 6. Scoring will be as follows, for such singleton or Eliminator:-Singleton will score as listed below. Eliminators will score one half (2) of the below points. If John Doe, sends in a singleton he receives 1 point. Mr. Henry Eliminates this Singleton he receives 1/2 point and it takes off 1/2 point from Mr. Doe.

American verification 1 pt. Dominican Republic 2 pts.
Canadian """ 1 pt. Any Isle among West Indies 2 pts.
Mexican """ 1 pt. South American 3 pts.
Cuban """ 2 pts. European 5 pts.
Central America "" 2 pts. Australia & New Zealand 5 pts.

Two Points (2) will be awarded to EACH participant for EACH special NRC program he verifies. These verifications may be called in to the Official Manager at any time doing the contest.

- 7. This scoring applies only to those members residing in the United States or Canada. Members living in other parts of the universe, desiring to enter this contest will have to write in for special ratings.
 8. An ENTRY FEE of 25 cents will be assessed against each contestent which will placed in a general fund.
- 9. 1ST PRIZE will be \$5.00----Second PRIZE will be \$2.50--- THIRD PRIZE will be 1 years Subscription to NRC or RADEX. There also will be other prizes to be Donated from time to time.
- 10. In case of ties a prize identical with that tied for will be awarded to each tying contestant.
- ll. At the end of the contest, the leading contestants will have to forward all VERIFICATIONS to the Contest Manager for General Inspection. The veries will be called in only in case of disputes. In this case any contestant entering a false Eliminator or Singleton will forfeit 10 points for the false entry. A committee of 9 members to be judges in this case.
- 12. We reserve the right to amend any of these rules at any time it may be deemed advisable to do so, this will first be placed befor the Board foramendment.

--NEW STATION CONTEST--

We wish to announce that Dick Cooper has been appointed official manager for the contest that we suggested several weeks ago. Since Dick will also be acting as on of the BCE Editors, the contest will serve to keep him informed of new stations developements and he will be able to pass along to all members by publishing the tips in the bulletin. We have received the following and publish it as the OFFICIAL RULES for the

1. The contest will begin October 15, 1938 and end April 15 1939.

2. All NRCers are eligible for participation except the contest manager.

3. Stations to be eliminated are those USA stations not as yet on the air.

4. Scoring will be as follows:-

(a) FIVE POINTS shall be awarded to the first person hearing and eligible station. The reception must be backed up by a verification showing date and hour of reception but will be submitted

for inspection unless a controversy arises.

(b) FIVE POINTS shall be awarded to the person who receives the first verification from and eligible station. In all probability these points will go to the same person first hearing the station, but occasionally stations are slow to send out verifications, and we beleive this rule will serve to speed up veries from new stations that may be a bit slow in replying.

(c) FIVE POINTS will be awarded to EACH participant for EACH Special NRC program that he reports and verifies. The verie will be

called for only in case of dispute.

(d) Should any USA station change call letters, the station becomes immediately eligible for the contest and the same rules apply as to new stations.

5. An ENTRY FEE of 25 cents will be assessed against each contestant which will be turned back into a general fund, for this contest only.

6. 1st PRIZE will be \$2.50---2nd PRIZE will be 1 year subscription to the NRC. Possibilites of other prizes to me made at an later date.

7. In case of ties a prize identical with that tied for will be awarded

to each tying contestant.

8. Each person intending to enter should signify such intention by dropping a card to the contest manager. However, new entrants will be accepted at any time during the contest.

9. Disputes will be arbitrated by the Board of Directors.

Joe Brauner-Williamsville N.Y. Well a nother nice report from our friend Joe. By the way Joe has approximately 1250 veries to date. Well to go into Joes report, WHAI was possitively indentified one morning and verified promptly, they were allso heard Friday morning with flood bulletins over WEDC's testing. WSNJ, a rare one, showed up here twice around the middle of the month during the 6 AM EST sign on, this is a daily weekday program according to the station, received three verie from WSNJ, one each from the front office, engineering Dept, and the early program announcer. Lately WHAI and WSNJ are not coming thru, ESBC allways hogging 1210 at 6 oclock, WGNY was caught signing on one morning at that hour. Had quite a time on 1210 and just capped it off this morning and friday morning by logging WCOU, hadnt been tuning at 5 so miseed them, got this one directly thru your tips. With WGAN logged on the election night I have the actives in N.E. cleaned up again.

Other new DX consists of KRIC and WHLS logged on the FCC checks. KRIC was a surprise here as the FCC had notified a fellow DXer that KRIC was to check on regular sked. And lastly KTRI was logged with an R/7 signal this morning with a football game. Plenty interference. By the way many southwestern and central western colleges and schools are playing night football, usually friday night and some rare catches out there stay on late to broadcast them, the KTRI game was originating at WHO and

was being relayed by KGLO, WOC, KTRI and maybe others.

CMCA 1350 kc Experimental DX program at 3:35 AM on. From 8 to 11 PM another excellent evening of Cuban reception. Sept 24- From 2 AM on into wee hrs of the AM NBC CBS and MBS networks on with Dance music and latest news of European and New England Floods. Poor chance for any DX.
