INTERNATIONAL DX DIGEST

You fellows seem to want to give the dying DX season a parting kick or two as it passes on, so we have a little information this week of a DX nature. So let's on with the news----

NORTH AMERICA

CUBA--CMS reports a bit of a problem. It appears that the proposed station on 1450 Kcs. in Santa Clara is on the air, but the harmonic has been heard on 2880 Kcs. and this indicates that they are on 1440 Kcs. He doesn't have either call or address, so no report has been sent. On 3/15 CMBG (1360) Havana, was logged at 0600 and CMKI (1350) Puerto Padre, was logged at 0610. (CMS) RE reports his verie from CMCY and your editor also received one. FW reports he has a verie from CMBZ with miniature marracos, and a miniature Cuban flag. Says a coin was enclosed, but was lost in the mail. JB has logged CMCU (660) on 3/16 at 2015, a novelty to him, as he says evening DXing was out at his old location due to images.

MEXICO--JB is reveling in a forest of Mexicans he hasn't logged yet. Has heard XEW, XERB, XEG, XEBG, XERF, KEX, XEQR, XEAC, XEPH, XEBZ, XEAA, XEQK, XESM, XEMC, and XEN. Has reported only KEX, as he is saving the rest for next year's contest. He reports listening to 1030 Kcs. on 3/7 at 2200, but identified as "Radio Excelsior". Later in evening he did hear XEQR identified, but wonders who "Radio Excelsior" was. CMS reports the third harmonic of XEFW in Tampico on 2430 Kcs. XELQ (570) Morelia, was heard at 0110 on 2/28. (CMS) RHM reports a verie in from XEJ (970) Ciudad Juarez, Chih. Signer is M. D. Heredia. HSW reports that XEMO (860) Tijuana, B. Cfa., can be heard in the east on Tuesday mornings to 0300 sign-off with KONO silent. Was heard 3/24 with program, "Starlight Serenade" using American records sponsored by the "Magic Corner", all in English with sign-off at 0300 in English and Spanish. FV logged and reported XEWA (540).

ALASKA--RHM reports hearing KIFW (1230) Sitka, with frequency check as listed on 4th Monday. Report out.

BERMUDA--CMS says he heard ZEM1 (1235) Pembroke, testing at 0400 on 2/23. NM reports a verie from Steve Mann with thanks to him for a difficult verifier.

PANAMA--HOCH is apparently operating on 1475 Kcs., as CMS has heard their harmonic on 2950 Kcs.

COSTA RICA--CMS logged TIGPH (605) San Jose, at 2300 on 2/23. RA reports his verie from TIDCR (625) San Jose, usual folder-card and still signed by R. R. Dorado.

DOMINICAN REPUBLIC--RA has his verie from HI3A, Santiago. Was signed, but signer not legible. Replied to Spanish letter.

PUERTO RICO--CMS reports that WWWV (1520) Rio Piedras, was heard at 0445 on 3/16, apparently signing on at 0430 weekdays. RE comments that his verie from AHD is overdue and wonders if others are also having trouble.

GUATEMALA--HS reports his verie from TGW (680) was signed by Carlos Alberto Marraquin G., Oficial de la Secretaria de TGW.

UNITED STATES--From RP news that he has verified WINS (1010) New York, WNAC, Boston, and WTIC, Hartford, with the latter also sending a folder describing the station and its personnel.

SOUTH AMERICA

VENEZUELA--GH notes to Roy Patrick that YVME is the call for 4.8 Mc. The CBW or medium wave station is YVMF on 1120 Kcs. Both calls are given on both frequencies, but the above is correct according to their letterhead. CMS adds that he has logged YVKL (590) Caracas, on 2/22 at 0540, a Sunday morning.

URUGUAY--CMS reports a definite verification in from CX-14. Also heard CX-28 (1090) Montevideo, on 3/1 at 0405. Tentatively logged CX-12 (770) Montevideo, on 3/4 at 2130. (All this from CMS)

April 4, 1963

BRAZIL--CMS heard PRE-7 (1410) Sao Paulo, on 3/3 at 0445. Also PRG-9 (1100) Sao Paulo, at 0445 on 3/3. This station uses the slogan "Radio Nacional", not "Radio Excelsior". This checks with information in World Radio Handbook, whose QRA he used in reporting. (All-CMS)

ARGENTINA--RP reports that LR-3 "Radio Belgrano" (950) has often been heard around 2330 GMT during the past two weeks, but with lots of static.

EUROPE

AUSTRIA--RA reports a verie from R. W. R., Vienna, in English, a letter signed by a member of the Technical Dept.

FRANCE--RA has a verie from Lilli I, a letter signed by R. Carpentier. CMS heard Rennes (674) on 2/19 at 0115. Also Lille I (1376) same date at 0145.

WALES--CMS reports the Welsh group logged on 881 Kcs. on 2/19 at 0215.

AZORES--RP reports that the AMERICAN FORCES STATION has been heard on about 1486 Kcs. at 0030 GMT. Station is located at Lagens Field, heard on 3/20 and 3/21 with S-3 to 4 signals. "Atlantic Regional" at Ponta Delgada is heard on about 1214 Kcs. at 0010 after the BBC has signed off. (This is GMT). Program of popular music heard until 0100. This one heard on 3/20.

MONACO--RP reports that Monte Carlo (1466) now sends out a nice QSL card instead of letter formerly sent. I think that several of our reporters now have that card.

AFRICA

ALGERIA--CMS reports his verie in from Algiers II (890).

TANGIER--RP notes reception of "Radio Tangier" on 1679 Kcs., heard with a good signal from 2300-2400 GMT (1800-1900 EST). Appears to be a new station.

ASIA

JAPAN--RHM says that although he has logged 23 Japanese stations this past season, only APRS-Tokyo (770) has been coming through lately. Quite good from 0600 on 3/23.

OCEANIA

NEW ZEALAND--RHM has logged 4ZB (1040) Dunedin, on 3/22 at 0500 sign-off, which was in clear with WHO off. 1ZB (1070) Auckland, logged on 3/23 at 0530 sign-off with KNX off Monday morning. 3YA (690) Christchurch, logged on 3/23 at 0500. All signals S-9 plus, but seldom over QSA-1. Reports sent to all three. (RHM) CMS has heard 3YA (570) Wellington and 1YZ (800) Rotorua. He has a definite verification from 1YC on usual NZBC card.

HAWAII--CMS heard KAHU (920) Waipahu, on 3/9 at 0430. This was a Sunday morning.

AUSTRALIA--CMS reports definite varies in from 5CL and 2NR. Both on ABC cards. 5DR (1500) Darwin was tentatively logged on 3/1 at 0530. (CMS) RM notes that 2WL (1430) Wollongong, is the only Aussie he has heard recently. Logged on 3/29 around 0530. SRM logged 2WL on 3/28 on 1430 Kcs. from 0355-0425 with some fading. Your editor has a mystery which he hopes may be Australian. On 3/31 he logged a station on 1540 Kcs. with classical music. It was logged from 0405-0510, and no announcements were heard. Music continued almost uninterrupted. It was too weak for anything in this country except west coast, and the station had the characteristic TP fade, going from S-7 to completely out. On peaks (S-7) there was QRM from a weaker station subject to the same type of fading. I am hopefully sending a report to 2CN in Canberra, figuring that the QRM came from 4GM which has a lower power. If anyone knows who the station was, let me know, even though you do crush my dreams of having heard an Aussie.

FIJI ISLANDS--JB says that he has a tentative report out to 3UZ (930), but since ZIV has changed to 2KW., he is sending them one too. Will let us know which one verified. Sort of hopes for the new country.

CMS reports a really screwy one. On 3/11 a station, apparently a beacon was heard on 1580 Kcs. at 0510 transmitting in CW the letter C followed by a long dash. Could come from Central America like HCC, but it sounded like a TP. Any ideas. He also had a Spanish station on 1480 Kcs. several evenings signing off at 2130. Seemed to have an H in his call. Wonders if it might be HI2H, assigned to 1490 Kcs. Thinks that 2130 is early for a Colombian or Equadorian to sign off.

RHM has one on 3/30 from 0400-0415 on 980 and 1410 Kcs. A man announcer in what may have been Spanish, but slower and clearer than most Spanish heard. Fades badly, and not definitely identified. Who would have identical programs on 980 and 1410 at that hour. Not Jap or AFRS. TP's were not readable, so not likely. Anyone help? (Could have been PRE-7 and PRE-8-FV)

I've tried CMBC about four times with no luck. Used to do the same with XEFO in Mexico City, when lo and behold the fourth year on the fourth try, a nice verie came back. XEMC took three years and a like number of reports. I always say, "Keep trying". I even send a report to XEQK every year. Some year, he too will verify.

Roger Anderson says it has been a top year for him. He has 55 veries so far out of 91 reports with plenty still very hopeful. Norm Maguire lauds the Japs with 17 verified out of 18 reports. His late verie from JOOC would appear to be a prize, as all logs list it as 500 watts, a nice catch. 2QW verified to Pete McKenna saying that they had another report from Albuquerque, but no verie yet to Norm, who feels sure he was the other reporter.
