Best catch as far as only 15 miles from my home town. 2/17- WAVY-1350 Va. w/heavy QRM. Possible CKEW-1000 N.S. but not positive. VOXM-590 from 8-10pm, weak, but very clear. Possible WPDQ-600 as heard Hacksonville mentioned but no ID. WFAA-820 w/fair signal at 8:13pm & several IDs. Is C---970 Frederickton N.B. on the air yet & if so, what are their calls? 2/18- VOXM-590 in, good signal. CBN-640 in at 7:35pm w/good signal & QRM. WWRL-1600 still coming in fairly strong which surprises me. I've tried for the last two years to hear them in Maine but no luck. The complete outfit consists of a BC-221-AF Frequency Meter, BC-221-AH Case, RA-1330A Rect. Power Unit & Calibration Book from an SCR-211-Q so you can see the Units are from different types of Frequency Meters. Questions: The bague info I have from two sources lists the accuracy at 0.01% or plus or minus 500 cycles & 300 cycles. Whic is correct? And what modifications if any can be made in the circuit for more accuracy especially in the BCB range? All I have to do now is recalibrate the meter & list the new dial settings in the calibration book & get some info on the correct operation. I don't believe I ever mentioned it before but the majority of my stateside military service which was about 1 1/2 years out of over six was spent at Ft. Monmouth, NJ attending the Frequency Propagation Course which Jim Lee is not going through & the Radar Repair Course. And, also W9XC Mitchelville, Iowa, in 1942, w/150,000 watts! Most of the later DXers will not remember all of these smateur-type calls which were used on the BCB around this period, and previously, particularly WLXBS (now WBRY), W2XR (now WQXR), W6XAI (now KPMC) and W9XBY (which became KXBY for a short time). And how about KE2XZG New York, which used these calls in 1959, w/50,000 watts? If you need some space to fill up these pages during this coming Summer, I'd like to send along an article on "Reminiscing with some Old-Timers" which would make some of the current DXers' mouths water!
