WHAT TO LOOK FOR: KAAM uses 4 guyed towers next to Road 1380 (known also as Belt Line Road North) near Carrollton, Texas. Only 2 towers are lit at night. KLDD has 3 guyed towers SE of the intersection of Belt Line Road North and Belt Line Road West near Coppell, Texas just north of the I-635 extension to the Dallas-Ft. Worth airport. At one time, that SW tower (slightly separated from other two) was used by WBAP.

- 970 WHA WI MADISON - regarding DE-PQ's unID of 12/5, WHA is definitely on at that time, and their 51 watts gets out surprisingly well (DS-TN)
- 980 UNID ?? - 12/18 1650 good with wx and ID as either K-89 or K-99 into ad for drugstore in downtown York; format was not one that would be normally broadcast on a lower-channel FM station (88-92 MHz); the only York I can find on 980 is in South Carolina, but nothing seems to match; this is a REAL mystery, so I'll let someone else out there figure it out for me (RD-IA1)
- 990 UNID ?? - 12/22 1709 fair with Kansas City Chiefs FB; my hunch would be KRMO or much-needed KRSL (RD-IA1)
- 3160 UNID ?? - 1/5 2140-2200 several CLA piano selections over/under WYNS/WOBM/WJJD, buried by fade before 2200; who? (RJE-PA)
- 1256 WDMA VA DANVILLE - editor is right [Why, thank you! - Ed.], this is JK-VA's unID of 11/26; verie signer is (or used to be) Tim L. Walker, Engineer (BG-VA)
- 1360 WV/SJ NJ WASHINGTON TOWNSHIP - sure sounds like MJ-MI's unID of 12/8 (Issue 13) using ###-9875 (###-WV/SJ) phone number; the new 1992 *MRC AM Radio Log* sure makes a DXer's life easier; I recommend everyone get a copy (REH-ON). . . seems a good match for MJ-MI's unID of 12/8 (DS-TN)

- WUVA NC ICARD TOWNSHIP - 1/8 0645 tent hrd with break in pgm for NBC News bulletin about President Bush's illness, with ID for what sounded like the now-famous WNNC; does this run NBC News? and is it on that early?? (RJE-PA)
- UNID ?? - 1/9 1730 fair with REL, sign-off @ 1730; possibly WI--? (LMC-NY)

## Gun lobby asks FCC to revive 'fairness'

**WASHINGTON** Claiming that publishers have a bias against gun owners, the National Rifle Assn. has asked the Federal Communications Commission to reinstate the Fairness Doctrine for public broadcasters.

The Fairness Doctrine, a long-standing FCC policy that required broadcasters to air both sides of a controversial issue, was thrown out in 1988 on grounds that a "scarcity" of media outlets no longer existed in light of the increased number of independent tv stations, radio stations and cable tv channels.

Jim Warner, assistant general counsel of the NRA, said his group wants a return of the rule for non-commercial broadcasters because "we think public broadcasting generally represents an extremely narrow spectrum of views to the detriment of other views."

Warner cited National Public Radio for a "bias" against the gun lobby, claiming the web has "explicitly and knowingly stated untruths" about the organiza-

tion in the past.

Warnersaid the Fairness Doctrine needs to be enforced because a scarcity of non-commercial outlets still exists in most cities, and taxpayers foot the bill.

Ironically, the attorney handling the NRA case is Bruce Fein, a former FCC general counsel who strongly advocated eliminating the Fairness Doctrine during his commission tenure.

# Formats

*Changes in programming status; reported by listeners*

I hope that everyone had a real nice holiday season. Our first Formats column for 1992 is rather unique, in that it offers some special features, including the often requested Dial Scan from the Bay Area. But first from your editor's area, WADS-690, Ansonia, has gone to a totally brokered Spanish and Portuguese format. Now, when time is not bought, the station is silent. One hears little of this formerly fine full service station on the air, which, of course, enhances the DX from 680 khz to 700 khz. And WFAS-1230, over in White Plains seems to be running adult standards, modifying its Westchester County news and talk format.

Unique item # 1 is a guide to Boston's Spanish radio. Before we get to this very interesting digest, prepared by Bruce Conti, of Nashua, NH, 45 miles north of Beantown, let me note that the only Black (Boston's largest ethnic group) programming is found on WILD - 1090, which is a full service 5000 watt daytimer for the Black community. The only other Black programming of which I am aware in Beantown is found on Sunday morning on WWEA - 740, when the gospel preachers carried over from the station's WLVG days still do their thing. WWEA otherwise is an automated jukebox, with rock and roll and environmental programming. Here, courtesy of Bruce is Spanish Radio for when you are driving down Commonwealth Avenue listening to 1510, you will know that you are not listening to all news in Mexico City.

- 800 WCCM Lawrence - "Radio Ochocientos". Spanish local news, information, salsa and merengue music nights, Red Sox in Spanish. English during the day, and when carrying live local H.S. sports.
- 950 WROL Boston - Flagship station for Red Sox games in Spanish. English religion in the AM, otherwise a variety of English, Spanish, and Irish programming.
- 1060 WBIV Natick - (My candidate for the most mis-targeted radio station in the entire USA - TF). Spanish Christian programming (for all of the Spanish Christians in Wellesley, Concord, and Weston). Key buzz words are "El Dios" (God), "El Volveria" (He will return), "La palabra" (The Word)...

Greetings from the NRC's only 59 year member! My 1st membership card bears the date 11/17/33. I started to log DX during the winter of 1925/26 but did not know about veries until I joined the club after hearing president Bob Weaver conduct a DX program on WORK-1320 York, PA. My BCB veries now total 6135 out of 6964 stations logged in 116 countries, all from the same location. Some recent veries have come from KCYK-590 (plus a CM and 2 cassettes of CW music!), WRPM-830 (plus CM, BS, etc.), WAMA-1550 (via WDAE), WECC-1190, WIGO-1170, WKXR-1260, WCEO-1260, WYLC-1260 & Dominica-595. WNZS-930 was logged at 5:30-6 PM on 12/7 and the verie states that I am the 1st DXer to report since their call change from WRXB, new format is all sports. Another new call is WYZQ-1120, formerly silent WCGM, logged 1/9 5:45-5:47 PM s/off, after the s/off of WDFU-1120, slogan is "Power 1120". One of my most wanted nearby stations, WYUS-930, showed up with a talk show on 12/14 and a clear ID at 5:30 PM. Other recent loggings include WQGR-1550 on 12/31, WGKA-1190 on 12/31, WBBC-1440 at 4:47-4:55 PM on 1/6 w/oldies as noted by our ED in his 1/6 MUSING w/B-93.5 (FM) ID's, WSTH-540 on 1/10 6:25-6:33 AM & WFKB-870 on 1/13 5:20-5:30 PM s/off w/singing of The Lords Prayer. A mystery is CHNO-550 programming heard on 920 at 5:53-5:57 AM on 1/11 w/NO-55 ID's & promos and Sudbury mentions (possibly unnc KCYK-920??). I've also been logging/verifying those 1 watt MEDFAR beacons between 1620 & 1700 khz. Those heard recently are RGQ-1650 Berwick, PA; RD & DCH-1635 Berlin, MD; DAW-1641.9 Greer, SC; VA-1656.7 Smith Mtn Lake, VA.; GDY-1662.5 Elliston, VA., & QYV-1689 Donora, PA. (And thanks, Kermit, for the kind words! But I still have this whistle in my ears on windy days since I've started doing this column that I just can't explain-hi!-DWS)

#### HEN DANGERFIELD - 202 GOVERNORS DRIVE - WALLINGFORD, PA 19086

My membership goes back to 1958 so I figure I'm OK for the 25 year issue. And if I'd known about the NRC prior to 1958, I would have surely joined because I've been a DXer since the early 30's. However, I didn't begin collecting veries until I joined the club and I have virtually stopped collecting them at this point although still doing a daily check of the MW band and keeping notes. My favorite achievement is having 120 countries verified out of about 125 logged. The location here is between Philadelphia & Wilmington, DE and has been a good one for TA's. My 1930 DX years were spent in Pittsburgh, and after 3 years in the Army during WW2 (2 of them in Europe), I settled permanently in this area. My main receiver since 1961 has been an hq180, and although it's had some problems, it has been very selective, sensitive & powerful DX tool. I used LW's through the 1960's and loops ever since, the present one and best being the San-serino loop. I've gotten an awful lot out of the NRC, wonderful DX info, enjoyable reading, and, of course, friends. What a difference from today! Of course, much of the DXing now is done during many of our trips and since 1970, have visited 70 countries on 6 continents. In a few days, we are going to Morocco (1st time) and Spains Costa del Sol & hope to drive to Gibraltar. My Sony 4910 will be going along. One note in closing, on 12/21, I heard WRLB-1460 Florence, NJ testing, not the greatest of signals. Will be reporting after the next trip.

Greetings fellow dial twisters! It boggles my mind to realize that I have been a member of this great organization for 25 years. When I joined as a 16 year old in 1966, DX NEWS was mimeographed by Richard H. Cooper in Kittanning, PA. (And came via 3rd class mail, next day-remember that?-DWS) The column editors were John Callerman, Joe Brauner & Ernie Cooper. A few of the other young members in the club were Jeff Kadet, Dave Schmidt & Wayne Heinen (of Orchard Park, NY). I have many fond memories of attending DXN publishing sessions here in the Boston area between 1968-73. I was only a peripheral member of the publishing committee. The guys who did most of the work were Gordon Nelson & Big George Kelley. Most of the sessions were held at NRC HQ - Gordon's house in Watertown. We also had some party type sessions at Geoff Fox's place - the WRYT-950 xmtr site in Saugus. Geoff, now the weatherman at Ch. 8 in New Haven, was a part-time announcer at WRYT. When the station was off the air, he would connect his receiver to the WRYT antenna! My 1st convention was at Hasbrouck Heights, NJ in 1970, hosted by Russ Edmunds. I drove down from Boston with Big George & Randy Kane and it was great fun! I remember meeting ERC, Cesar Obijo & this young guy named Frank Waldron from Matawan, NJ. Some of my 'DX Thrills' from the early days were: KDON-1460 alone on the channel around 3 AM on a Monday AM in Oct. 67, KORB-650 weak but alone with WSM off around 2:30 AM on an MM in Dec.67, also AFRTS-780 at Ramey AFB, PR (50 watts) on a Monday AM March 71, I believe WBBM was inaudible because of auroral conditions. My favorite type of DX has always been one weak signal alone on a channel, occasionally fading below the noise level and then returning. I also enjoy DX on a car radio at an ocean beach. I have heard many TA's such as Senegal-725, Morocco-819/878 & Algeria-891 with the sun still shining on the western horizon. I also enjoy mid day DX on the car radio at the beach. From any N or E facing beach on Cape Cod, one can easily hear CHTN-720 at high noon! I have always wanted to hear a Cuban at mid-day & I know that MARK CONNELLY has accomplished this, from W Dennis Beach, I believe. In closing, I would like to say that communication with other DXers makes the hobby much more enjoyable. It is great to chat DX with someone in person, via letter or ham radio. Whatever the means, communicate! Best wishes to you all!

It's been many a year since I have Mused so thought now was a fine time to join the 'Old Timers' for a report. It has been more than 40 years since I joined the NRC. Even though I don't DX the late hours any more, I still keep log books up to date with each DX NEWS and absorb all the info. I am 68 years of age, retired from the US Gov't as a cartographer with the US Geological Survey in 1978. We have 3 grown children, all 'released into the wild'. I began DXing in 1938 in hometown Jamestown, NY where the first verie was WIPW in KS. Further DXing was done at Grove City College (PA) and aboard LST's in the US Navy during WW2. The remaining DXing has been Arlington. Through the years, I amassed 1159 verifications from 105 countries. Although it was all US stations for many years, it was in the remarkable early 50's that the foreign stations mesmerized me. How many of you recall the winters of 52-53, 53-54, 54-55, 64-65 & 65-66? In this semi-inland area, I verified 37 European & 12 African countries. 4 Asian & 6 Oceania ones followed. My best TA w/miles/watt was WIND/AFRS in Novasseur, French Morocco with 100 watts 1/11/55. The best thrills from the TA receptions were when the letters & cards rolled in from the USSR & 9 Eastern European countries. The real thrill came when the Australian-New Zealand reception broke through in March 53, October 53 & March 54. A perfect record of 25 veries from 25 reports to Australia & 8 veries for 9 reports to New Zealand. Veries from Fiji Islands, Tarawa & Tonga were also welcomed. Today, it would seem an impossibility to receive 4 stations from Australia with 500 watts. These past many years have been taken up with daytime DX here and at the fine coastal spots as Chincotague, VA.; Cape May, NJ; Dover, DE; Hatteras, NC; and 2nd home, Scientists Cliffs, MD. At home I DX at sunset during fall, winter & spring while I'm pursuing weather reports from 50kw clears in 19 eastern states for my daily amateur weather recordings. Have done weather data gathering for 35 years in my yard for the weather service. It's great how radio can be incorporated into ones other hobbies. My receivers are an HQ129X (1951), superior to my HQ180 (1966), 2 GE Superdials are used on trips. The great number of stations per frequency, the 24 hour NSPers, sideband splatter, forced me from formal DXing to these alternatives but I enjoy. May peace be with all for the new year & Good DX!

Time flies when your having fun! I joined the NRC in late 64 or early 65, although my 1st verie is dated May 30th, 1964 from WICU-1330 Erie, PA.
