Fred Vobbe - Lima, OH

Just a short review / comment about a product. Rust-oleum Hammer Finish Paint This past month I have been cleaning and organizing things, and needed to put a rack on my workbench for some of my ham equipment. The only rack I had was a small 8RU steel cabinet that was "Harris" blue, and looked beat to heck. It originally was used in a newsroom, so it was handled, scratched, and wrote on. A note on it indicated it was at least 30 years old. I found a product that I think is pretty good. Do you remember the old Bud rack cabinets with the "hammer finish"? The hammer finish was a black textured look, and unlike "wrinkletex" which had a rougher feel to it I was shopping in Lowes today and found they now stock a can of spray paint called "Rust-oleum Hammered". SKU 20066-7215, product 7215 Black. Cost \$5.97 p/can. This 12 oz can perked up an old cabinet pretty good. Step one was cleaning the cabinet. This was done by using 409 cleaner and a floor scrub brush. What was coming off the metal was pretty gross. After some clean water and more toweling, I used a heat gun to make sure all moisture was out of the screw threads and corners. I allowed it to dry, then used rubbing alcohol on a rag to get any traces of grease or sticky stuff off the cabinet. Usually it was what was remaining of old Scotch Tape and Masking Tape. Next, I applied the paint. When it goes on it appears to be basic black gloss, but after it sets up you can see the paint sort of separate into the textured pattern. I painted and then allowed it to dry for 24 hours and then inspected it for consistency, and then did a lighter overcoat. Pros & Cons? Cons: You have to keep moving back and forth and be careful not to apply too thick. Rust-oleum has engineered a larger opening on the spray applicator so if you have worked with their products before, it would be easy to over spray an area. Also, one can is just about good for one 19"w x 14"d x 16'h rack cabinet. I suspect that this paint dispenses more product per covering area than traditional Rust-oleum paint. Pros: The cabinet looks great! None of the original baby-blue was seen peaking through. There is some texture to the touch, but it looks like a 50s or 60s Bud Hammered black cabinet. For \$6.00, not a bad investment to make an old equipment rack look new again. Two thumbs up for Rust-oleum on this new product.

- Bruce Conti: My transatlantic antenna has been out of service. There's a short to ground somewhere in the loop. At first I thought it was the extremely wet snow shorting out the transformer connections at the base, but on a windy night I could see the entire spectrum coming in and out on the SDR IQ. There's a section of the antenna that's been high up in the tree canopy for some 15 years that probably needs to be replaced, but it's too cold making the wire too stiff to retrieve without pulling the whole thing down. I'll have to wait 'til warmer weather arrives before using the old wire to hoist a new antenna.

CFFX DX Test Final Report

Wow! What a good test this turned out to be. In spite of marginal conditions, the last few hours of CFFX on 960 kHz made it to both the east and west coast and even to Scotland. Only the southwest and the deep south appear to have been left out. A look at the CFFX daytime pattern explains why - a pretty significant null toward the south.

As with the KKMO test, the CFFX test was heard in Europe. Special congratulations this time go to Paul Crankshaw in Troon Scotland, who caught a couple Morse code IDs. The test also made it to the North American west coast.

Annunciation Radio signs on briefly tomorrow, via WTOD-AM 1560

From the Toledo Blade, via Fred Vobbe

A Toledo Catholic radio station will make its debut [February 3]. But it will be a limited engagement for Annunciation Radio, which is leasing two hours of airtime on WTOD-AM (1560).

"It's a baby step," said Deacon Michael Learned, president of the station's board of directors. "But it's a big baby step."

Annunciation's long-term goal is to broadcast on its own radio signal 24 hours a day, seven days a week - a goal that may not be too far off, Mr. Learned said. "We have reason to believe that we will be on the air with our own station by the end of the year," he said. "But we can't make any promises."

While the deals and details are still to be determined, Annunciation's board decided not to remain silent in the meantime. The station will be paying for the two-hour time slot, from noon to 2 p.m., every Sunday on WTOD.

"We're very, very excited about that," Mr. Learned said. "We're really charged up." The broadcasts will feature a mix of syndicated programming, mostly from Ave Maria Radio in Ann Arbor, along with "a little taste" of local programming, he said. There will be homilies by area priests and deacons, a calendar of events, and the Rev. Michael Dandurand will provide a look ahead at the "Saints of the Week."

Tomorrow, the homily will be delivered by the

Rev. Charles Singler, pastor of Rosary Cathedral Parish and director of worship for the Toledo Catholic Diocese. Bishop Leonard Blair will be the homilist on Feb. 10, Mr. Learned said. Annunciation will likely offer devotions and Catholic music programs, based on suggestions made by the public.

"We're working toward expanding our local programming, but for now it will be little vignettes, 90 seconds to three minutes long. It's not real expansive," Mr. Learned said.

The cost of starting a Catholic radio station can range from \$10,000 for a low-power FM signal in some areas of the country to as much as \$15 million in major cities, experts say. Annunciation Radio estimates that its start-up costs will be between \$750,000 and \$1 million, and the nonprofit station is counting on local Catholics to help meet that need, Mr. Learned said.

"People are responding wonderfully to this, but we're not rolling in the money," he said. "We have to pay for our time on the station and we need to build a cache so we'll have money to build our own station. We need all the help we can get." Annunciation is planning an informational and fund-raising banquet on April 25, he added.
