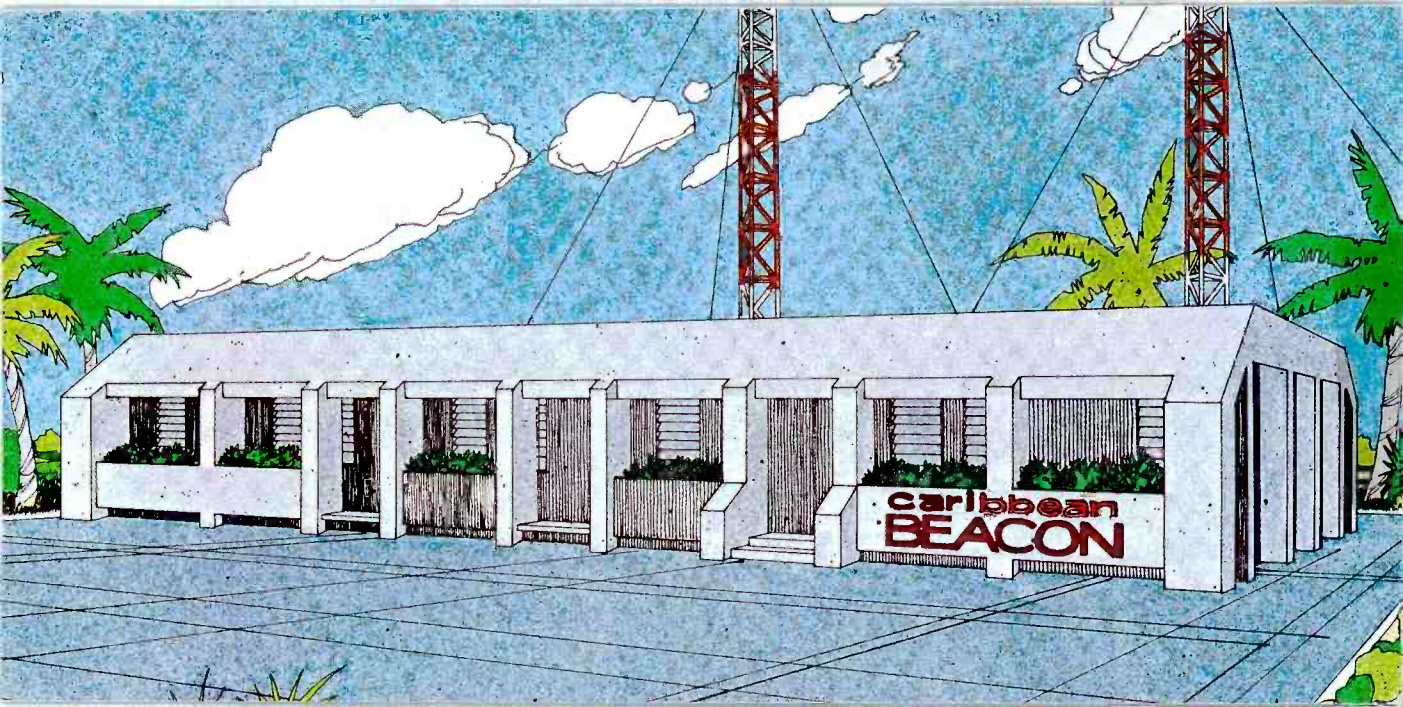

YOUR LETTER OF 2 DECEMBER RECD SOME TIME AGO, HAVE BEEN WAITING FOR ALL OF THE OTHER DX LETTERS TO COME IN BEFORE ANSWERING, AND NOW THAT I'M SURE ALL THAT EVER WILL ARRIVE ARE HERE, I HAD BETTER GET STARTED. I HAVE A COMPLETE LINE OF HOW THE SHOW WENT TO THE DIFFERENT SECTIONS OF THE COUNTRY, AND AM HAPPY TO SAY, THAT YOUR REPORT WAS ONE OF THE MOST COMPLETE, IF NOT THE MOST OF ALL THE ONES THAT CAME DOWN. YOU SURE DID PULL US IN IN THE BEST MANNER. I'M HAPPY AS THE DEVIL TO LEARN THAT YOU WERE ABLE TO HEAR JUST ABOUT THE ENTIRE PROGRAM AND THAT YOU REALLY ENJOYED SAME. IT WAS A PLEASURE INDEED TO DO WHAT I COULD FROM HERE, BUT IT'S EVEN MORE PLEASUREABLE BELIEVE ME, TO LEARN THAT WHAT YOU DID WENT OUT AND WAS PICKED UP IN THE STYLE AND FEELING THAT YOU TRIED TO GIVE IT. I WORKED THAT SHOW ALL BY MYSELF THAT MORNING. THERE WERE A FEW OF THE BOYS THAT SAID THEY WOULD BE UP TO ASSIST, BUT I GUESS IT WAS TOO EARLY FOR ALL OF THEM. IT'S FUNNY YOU KNOW, THAT YOU WEREN'T BOTHERED WITH ANY QRM, BECAUSE MOST OF THE OTHER REPORTS TOLD OF HEAVY QRM THAT ALL BUT BLOTTED OUT OUR SIGNAL A GOOD DEAL OF THE TIME, AND IN SOME SECTIONS, LIKE FURTHER NORTH, IN MASS. AND SOUTH IN THE DIRECTION OF WASHINGTON, OUR SIGNAL HARDLY CAME THRU, EXCEPT AT TIMES. SO YOU MY FRIEND WERE EITHER IN A LUCKY LOCALITY OR ELSE YOU HAVE A RECEIVER THAT IS PAR-EXCELLANCE.... FROM HERE, THE TECHNICAL END OF THE PROGRAM WENT PERFECT. OUR SIGNAL WAS SHARP AND CLEAR THROUGHOUT AND WE WERE IN GOOD MODULATION FOR THE WHOLE SHOW, AND EVERYTHING ELSE WENT FINE TOO.... THAT HUM THAT ALMOST ALL THE OTHERS MENTIONED SEEMED TO COME FROM A SOUTHERN STATION THAT WAS ON THE AIR ON OUR FREQ WITH AN OPEN CARRIER.

WELL, KERMIT, YOU CERTAINLY DID A MIGHTY GOOD JOB OF LOGGING US THOUGH, BELIEVE ME, SO THIS IS ANOTHER VERIFICATION FOR YOUR GROWING LIST, ADD THIS TO THE ONE I SENT YOU BEFORE.... BUT YOU HAD US ON THE BEAM ON DECEMBER 2ND 1945 FROM 4-5 AM E.S.T. AND THIS IS RADIO STATION WXLQ, 1240 KCS, 50 WATTS, UNITED STATES ARMED FORCES FROM FORT BELL IN BERMUDA. MANY HAPPY RETURNS OF THE DAY TO YOU, SEASONS GREETINGS FROM ALL OF US HERE, AND HERE'S WISHING YOU

MY DEAR RADIO FRIEND,

IT PLEASES ME UNENDING AND MAKES ME VERY HAPPY INDEED TO VERIFY YOUR RECEPTION OF OUR RADIO STATION W X L Q DOWN HERE AT FORT BELL IN BERMUDA.

YOUR LOG WAS PERFECT FOR THE TIME WE CAME THRU. YOU "SURE" WERE TUNED TO WXLQ "1240 ON YOUR DIAL". YOUR LETTER COVERED JUST ABOUT EVERY LITTLE THING WE WOULD BE INTERESTED IN KNOWING. YOU DIDN'T LEAVE OUT A THING, IT WAS REAL PLEASURE INDEED RECEIVING YOUR PERFECTLY WRITTEN LETTER AND CONGRATS TOO ON SPLENDID LOGGING O.M. AS YOU SAY, YOU RECEIVED A VERY PLEASANT SURPRISE WHEN YOU HEARD OUR CALL LETTERS COME THRU, JUST AS BIG A SURPRISE I BET, FOR US TO LEARN THAT OUR SIGNAL REACHED INTO YOUR DOMAIN. IT WAS A FINE TWO WAY SURPRISE IF YOU ASK ME.

GIVING CREDIT WHERE CREDIT IS DUE, I BELIEVE THAT ALL SHOULD GO TO OUR TECHNICIAN IN CHARGE OF THE RIG. IT WAS SGT METZNER WHO PUT IT ALL TOGETHER FROM A PILE OF SPARE, BROKEN AND PERSONAL PARTS AND SOME G.I. EQUIPMENT. HE STARTED THE SET GOING AND HAS KEPT IT GOING NOW FOR ABOUT 18 MONTHS. THE CONGRATULATIONS YOU OFFERED ON OUR FINE, EFFICIENT TRANSMITTING EQUIPMENT CERTAINLY WELL DESERVINGLY GO TO HIM. MY JOB IS TO RUN THE STATION AND DO ALL THE PLANNING AND TALKING. BETWEEN THE BOTH OF US WE MANAGE SOMEHOW. YOU WILL BE SURPRISED TO LEARN TOO, THAT OUR SIGNAL WAS NOT COMING FROM A 250 WATT OUTFIT, BUT RATHER THEN A MERE "50" WATTS. HAVE WE BEEN COMING THRU OTHER MORNINGS AS WELL OR WAS THAT JUST AN ACCIDENTAL SKIP???

I'M HONORED TO BE YOUR ONLY REPRESENTATIVE FROM BERMUDA IN YOUR FILES. I'M GLAD THE FIRST ONE WAS AN AMERICAN ARMED FORCES STATION. LATER ON, YOU MIGHT ADD ANOTHER FROM HERE TO YOUR FILES, FOR WHEN WE GO OFF THE AIR WITHIN THE NEXT FEW MONTHS, A CIVILIAN BERMUDA GOVERNMENT RIG WILL TAKE ITS PLACE.

I'M SURE YOU'RE INTERESTING IN SOME OF THE VERY ALL-IMPORTANT FACTS BEHIND OUR OPERATION AND SOME OF THE TECHNICAL DOPE, AND HERE IT IS....

I am in receipt of your letter dated January 31st, and was very pleased to have a report from you on our signal strength, modulation and tone. A check on our log confirmed your description as accurate, both time and program, local time being 6:29 A.M. The weather here was fair and cloudless and the temperature was about 75° fahrenheit.

We broadcast on two frequencies -:

Transmitter No. 1 ---- 950 K.C. 1.5 Kw. RCA Model 52


Transmitter No. 2 -----1040 K.C. 50 watt Collins 32 RA

The program you received is undoubtedly from our 50 watt Collins, situated on the seashore, 1 mile south of our studio, and relayed through overhead lines to the transmitter, through a coaxial cable to a 90 foot tower with three radial grounds extending into the water.

We appreciate reports from listeners wherever they may be and look forward to a second report from you on reception from our 1.5 Kw. Our schedule is as follows: Monday to Saturday, 6:29 A.M. to 11:00 P.M. Sunday, 10:00 A.M. to 11:00 P.M.

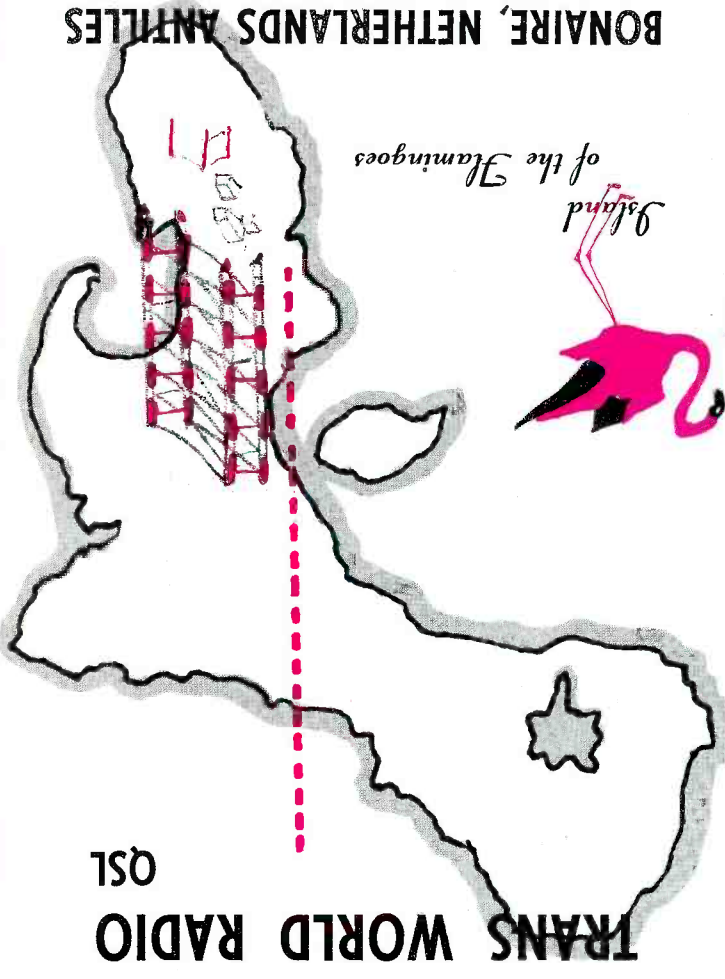

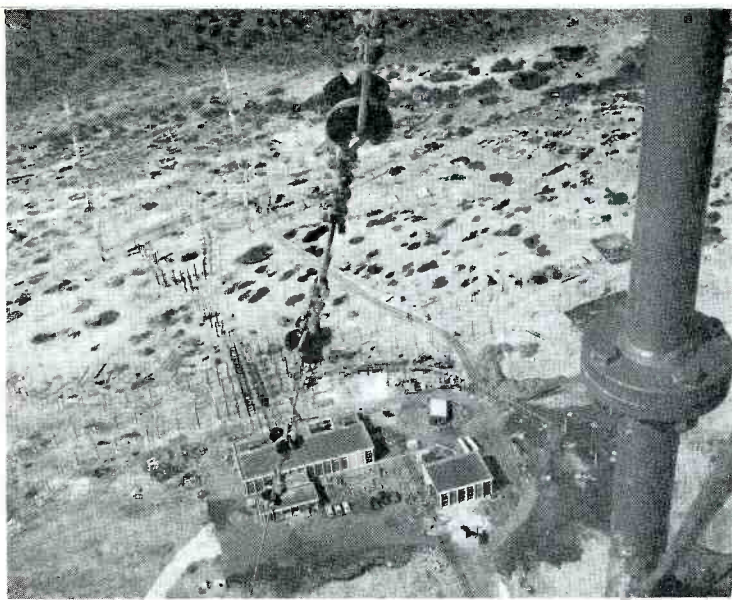

We at Radio Victoria wish to welcome you to our listening audience. We would like to acknowledge your reception report of Sept 6, 1962 as being an accurate report of our station at that time and date.

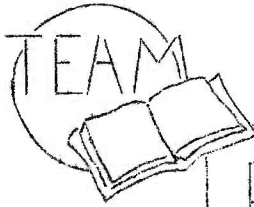
Radio Victoria is one of 27 missionary radio stations proclaiming the Gospel of our Lord Jesus Christ throughout the world. This station is sponsored by The Evangelical Alliance Mission of Chicago, Ill., U.S.A.. We broadcast from 9:00 A.M. to 11:00 P.M. (local time), in four languages--English, Spanish, Dutch and Papiamento which is the local language. This station went on the air in 1958 with a 5Kw Gates transmitter, on 920Kc's; then we have converted our transmitter to 10Kw's and moved to 905Kc's. This shift of frequency was due to local interference. Also it was our desire to find a clearer frequency. We use (2) 3X2500's in parallel driven by (2) push pull 3X2500's. Our line current is 14.1 amps into a 50 ohm coaxial line. We deliver 11.0 amps into a 300~~ft~~ foot marchoni antenna.

DX-ing is a new venture for us here on Aruba. This fall, on the first of each month, at 12 midnight (local time) E.S.T. plus half-hour we will be carrying on a special DXing program. We hope that we might receive a report from your area. In the past six months we have heard from countries such as England, Sweden, Norway, Denmark and the United States. In the States we have been heard in New York, New Jersey, Maryland, Texas, Vermont, Illinois, Connecticut, Massachusetts and Pennsylvania. Since we are starting to DX we hope to hear from many more countries.

Enclosed is some literature about our station and some other literature that might help you in your life. Thank you for your letter and we hope to be hearing from you again.

Dear DX-er:

We at Radio Victoria wish to thank you for your reception report. We are glad to acknowledge as accurate your report of reception of our signal as noted on the enclosed Radio Victoria official letterhead.

Radio Victoria is one of about 45 missionary radio stations proclaiming the Good News of Jesus Christ throughout the world. Radio Victoria is owned and operated by The Evangelical Alliance Mission of Wheaton, Illinois, U.S.A., and first went on the air in 1958 with a 5kw Gates transmitter on 920 KHz. Since then the transmitter has been converted to 10 kw, and has changed to 925 KHz to reduce adjacent channel interference. We broadcast from 1000 to 0100 Greenwich Mean Time or 0600 to 2100 local time (Atlantic Standard Time) in Dutch, English, Spanish and Papiamento which is the local language. 

Thank you for your reception report on Radio Curom - Z 86. I have checked the log and can verify your report for reception of Z 86 on March 5, 1984 between the hours of 02.43 to 0301 Curacao time. I was very pleased that the reception was strong and clear and was intrigued by the fact that CJBC in Toronto did not dominate the frequency. There is another 50Kw station on 860Khz in Santo Domingo by the name of Radb Clarin which we can hear when we are off the air due to transmitter problems during the day and at night we usually hear a 10Kw station located in Columbia on our frequency.

I myself used to own a Hammurlaund HQ-180 and enjoyed it very much. I presently have owned since the 60's a Drake R4A with the necessary crystals to receive the shortwave bands. I am not familiar with SM-2 Space Magnet and wondered how it performed next to the Dymek ferrite rod? Is the SM-2 still available? If you have a chance I would appreciate any information on your ferrite rod. I am also enclosing a listing of other Antillian stations currently on the air.

As for equipment, Radio Curom uses a Harris 10Kw plate modulated transmitter as our main and for a backup we use a RCA 1 Kw. Our tower is slightly longer than 90' and we use a full set of 140 radials 1/4 wavelength long for improved efficiency.

We are currently on our 50th year of existence and will have new studios this year and will also have on the air a 4 Kw FM at 95.5 MHz.



March 5th the day you received Radio Curom happened to be the day after Carnaval. If you per chance received us a few hours earlier you would have heard the music played by local musicians live on trucks and floats as we were broadcasting live from the Carnaval parade route. In fact we had 5 different broadcast stations along the parade equipped with wireless microphones so one tuned to Z-86 wouldn't miss anything as reports were broadcast continually from all the sites. It was a fun time for all the staff but also exhausting.

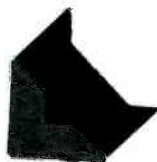
