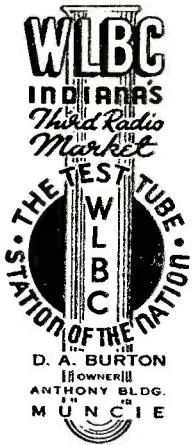


Your verification letter of October 9, is appreciated and there is no doubt about you receiving our signal there which exactly corresponds with our logging of that date.



It is certainly a pleasure receiving asreception report as neat and detailed as yours. Almost thought is was a resume at first.

Please consider this letter as verification of the program material you listed as being heard. QSL cards are at the printers, so hang tight.

We have found from previous reports that most of the Pennsylvania listening area is relatively free from atmospheric interference, and very little interference from XEDM. As indicated in your report, your area is no exception. Maryland however is someting else altogether. A report from the Baltimore area indicated S-7 to S-9 on WJVA, with an occasional rise to 10 over S-9. Interference from noise gave a S-5 to S-8 reading with XEDM fading in and out heavily from S-5 to 20 over S-9. Same test. Same night. Two reports from Alden, N.Y., Jerry Monroe and Josh Hill, indicated about midway between you and the report from Maryland. Isn't radio fun?!?!

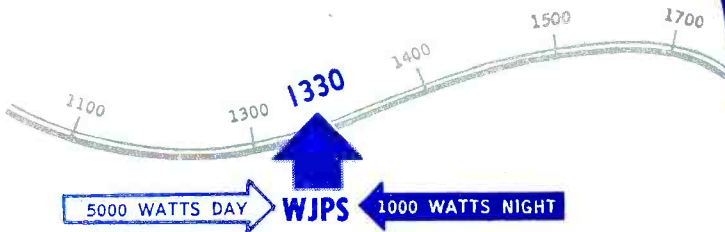

This will verify your reception report of our equipment tests. To date, we have had a great many reports from various sections of the country, and are very gratified with the results of our tests. It is very helpful to receive listeners reports such as yours, as it is the only way we have of knowing how our signal is getting out.

Here at WJPS, we are using a Federal Radio and Telephone, five kilowatt transmitter, Model 196A. Our antenna consists of three, 200 foot International Derrick, self-supporting towers. These towers are quarter wave spaced, and the line of towers is North 18 degrees East. For our daytime pattern, we use the two end towers with the North tower as reference. For our nighttime pattern, when power is reduced to one kilowatt, we utilize three towers with the center as reference.

Thank you for your good wishes, and hope you will favor us with more reports in the future.

I am in receipt of your letter dated December 15, and was very pleased to hear from you. I am glad that you receive our station so well and it comes in so clear.

We have a Raytheon Transmitter here, RA 1000, which is a 1000 watt transmitter of 1947 vintage. We run the final into a series fed 300 foot Wincharger Tower which very soon will have an added 17 feet of FM antenna. We have Raytheon studio equipment and Presto turntables.

Your copy was correct in every respect and if I had been keeping the log myself I don't think I could have done a more accurate job of it than what you have done. Everything was letter perfect.

Thanks for the Dx report. We were very happy to receive your very nice letter telling us that our little "coffee pot" was boiling hard enough to land a signal in your part of the country. I might add that your letter was rather nice after wading through a stack of cold, formal printed Dx forms.

The equipment here is, for the most part, Gates. The transmitter, freq. control unit, modulation monitor, and limiting amplifier are all Gates. The freq. monitor is a Doolittle and the tower is a 150 ft. Windcharger.

We have a two studio setup with a control room that doubles in brass by also housing the transmitter. The building is a large modernistic affair with four sloping plate glass windows set in the front. 

It is with our pleasure to inform you that you have correctly identified WGOM's signal while we were conducting our special test on Sunday night (Monday morning) January 6, 1975, between the hours of 2:45 AM and 3:30 AM Eastern Standard Time.

WGOM operates with a power of 250 watts on 860 kilohertz pumped out by a Collins #300J transmitter, two directional towers, #1 tower to the northeast having a height of 200 feet, #2 tower to the southwest having a height of 300 feet. The signal is fed to the towers in such a way as to produce a directional signal laying northwest, southeast and some to the southwest.

The 300 foot tower also supports WGOM's FM sister station's antenna (WMRI) it being a Jampro JCP-12 12 bay antenna circular polarized. The FM station being a 50 kw stereo station and automated. That transmitter is a Gates 10G 10 kw transmitter, and Schafer automation system.

We conducted a frequency check at that time and we were found to be 2.2 cycles high.

We thank you for your consideration and hope that you continue your fine hobby of DX listening. We also hope, when conditions permit, that you will listen for WGOM. See you next year?

This letter and enclosed "verification check" will verify your report of reception of Radio Station WIMS during its special DX test broadcast on March 25, 1990 from 3:30 A.M. to approximately 4:22 A.M., CST.

Our test program was divided into four segments -- the first 15 minutes was transmitted at 500 watts, day pattern, the second 15 minutes at 5000 watts, day pattern, the third 15 minutes at 5000 watts, night pattern and the final abbreviated segment at 5000 watts, day pattern. Our test program ended abruptly at about 4:22 A.M. due to a capacitor failure in our daytime phasing circuit. The WIMS daytime pattern is a lop-sided circle with major radiation to the southeast; the nighttime pattern is a "Figure 8" on a line 16° east of True North, the major lobe going to the northeast.

Thank you for your report; it was a pleasure doing this special test program for the NRC, but we were a bit disappointed with the response (only 4 reports received).



We were very pleased to receive your report, inasmuch as this was the first time this transmitter was on the air. It is a pleasure to receive a complete report such as yours, as it shows that keen observation was made of the signal.

Yes, you are correct about the low frequencies being missing from our transmissions. Our program line between studio and transmitter is 4 miles long and had not been properly set up and equalized at the time this test was run. It is now properly set and our quality is much improved.

Our radiator is a single 250 ft. Lehigh steel tower, guyed, uniform cross section. Our ground system consists of copper wire laid in radial fashion from the base of the antenna and bonded together there. There are 120 radials 300' long interspersed by 120 radials 50' long, buried 6". 42,000 feet of wire in all. The antenna is series fed with a conventional coupling unit and the power is brought from the transmitter house 350 feet away by means of coaxial line.

Our transmitter is manufactured by Gates Radio, Quincy, Ill. and uses a pair of 833A's in the final modulated by a pair of 833A's high level (Class B).

I tried with about 10 reports, but then realized that it would be too much, as I would still be doing it about December 25th. By the results of the preceding statement, you can realize that we had very good results from the broadcast. All reports were either verifiable by correct times of tones, or else word-for-word loggings of my IDs.

This letter is given to you as official verification of reception of radio station WNWI on November 6, 1966.

We received 46 reports from 20 states and also including 3 from Ontario and one from Quebec. The farthest report came from a listener in a car in Tampa, Florida. We also received good reports from Houston, Texas, and also one from a listener only 45 miles from 50kw WTIC.
