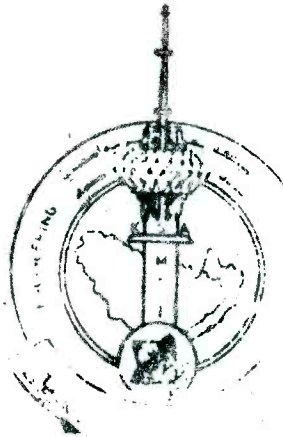


Dear Mr. Geary,

Thank you for your letter and tape reporting reception of our medium wave transmission on 844 KHz for the evening of the 6th of December. After listening to your tape I am pleased to confirm that you were in fact tuned to VSZ1. The clearest part of your tape, cut 3, was in fact one of our producers, Atiera, giving a report of the proceedings of our Legislative Council meetings, which were held at the begining of December.

The power output of our transmitter is 10KW radiating omnidirectionally from a three wire T. aerial 250 ft long on 180 ft masts.

We have now received several reports of reception in from the East coast of the United States. I am not quite sure whether this is an indication that we are operating efficiently or not. Anyway thanks for the report.

Dear Mr. Geary,

We feel that your report on reception of 2CN Canberra calls for a letter of congratulation as well as a verification card. This transmitter is one of the regional (or relay) stations of the Australian Broadcasting Commission: Canberra, the Federal Capital, has two of them (the other being 2CY), and 2CN is a quite low-powered transmitter, having an aerial power of only 2 kw. Your being able to hear 2CN on March 29th represents, of course, freak rather than conventional reception, because in some directions it is not audible very far beyond the immediate district in which Canberra is situated.

You may be interested in the enclosed lists of medium and short-wave transmitters that radiate the Home Service programmes of the A.B.C. These are, of course, quite distinct from the powerful transmitters of Radio Australia, the Overseas Service.

Thank you for your kind wishes, which we are happy to reciprocate. Perhaps you will be able to hear some of our other stations; if so, please send us a report as detailed as you can.

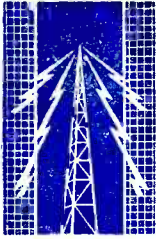

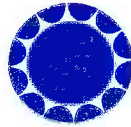



Thank you for your reception report and we have much pleasure in sending you our verification card.

1ZD has been operating for three years, today being our third 'birthday', and we operate on a power of 10,000 watts. Our studios are situated in Tauranga, a city with a population in excess of 20,000 and our program is sent via landlines leased from the New Zealand Post & Telegraph Department to our transmitter at Paengaroa 25 miles away on the coast. The transmitter itself is a 500 foot vertical radiator and is shared with Station 1YZ (800 k/c's) which has its studios in Rotorua which is NZ's thermal area and very popular with tourists.

Our station is fully commercial and our transmission times are 1800 - 0200 and 0530 - 1030 hours GMT. The studio equipment consists of RCA and Sony micophones, Ampex, Sony and Rola tape recorders and the remainder is constructed in our engineering workshops situated in Wellington.

Thank you for your kind remarks and we hope to hear from you sometime again in the future as conditions permit.

Reception conditions here in NZ are very good and there's scarcely any overseas countries yet to be logged by NZ DXers.

Dear Mr. Geary,

Thank you very much indeed for your letter of the 19th February reporting reception of 1YZ.

It was astonishing to us to receive a report from so far across the States as Walnut-port. We have considerable pleasure in confirming your reception of 1YZ Rotorua, and it may be of satisfaction to you to learn that you are by far the most distant point where 1YZ has been reported.

Our power is only 10 K.W. and the Wellington station of 60 K.W. has not reached much further than this great distance.

We first came on the air on 27/4/49. Our transmitter is on the Coast about 30 ~~air~~ miles from the Studios in Rotorua. The mast of 500 feet steel lattice-work is also the Antenna and was the first tower aerial to be used in New Zealand. The mast was built in Melbourne Australia, and the transmitter and studio equipment by Amalgamated Wireless Ltd. in Sydney, Australia. Rotorua is the centre of the thermal district and a tourist centre.

We have very good coverage of most of the Pacific Islands including Tarawa Island, known to your Marines. We have had a number of reports from California, and one from Carey in Ohio.

You might be interested to know that I was engineer at 2YA Wellington when we arranged a two-way conversation between New York and your Admiral Byrd on his first trip to the South Pole. When he came back I looked after his little fox-terrier "Igloo" (who flew with him over the Pole) while the Admiral made another broadcast. The two-way broadcast to New York was in those days a world record.

Many thanks for your report and perhaps we will hear from you again later in the year.

Dear Mr Geary,

Your letter written on 26th April was received here 7th May and I can assure you we were very pleased indeed with the excellent reception report which created more than a little excitement amongst our engineers. The information, painstakingly compiled by you, is greatly appreciated and I have much pleasure in confirming the details of this Station's transmission on 25th April. A formal verification card will be dispatched by surface mail and should reach you in a month or so, depending of course on the shipping situation which is grim at the moment, particularly to and from New Zealand.

You'll be interested to learn that your report is the first from the North American continent and the only one to be received here from a listening post at a distance greater than two thousand miles. We offer you our sincere congratulations on your successful logging.

Our studios and offices at 3YZ are in the main street of Greymouth but the transmitter is eleven miles south at a place called Kumara meaning "sweet potato". It has a power output of 10 k.w. unmodulated and is of Australian manufacture from a design essentially the same as that used by R.C.A. for 10 k.w. plate modulated transmitters. The radiator is a 400 ft. guyed tower sectionalized at 270 ft. and operated at an angle of 213 degrees.

Again, ever so many thanks for your accurately prepared report. The data on signal strength, modulation depth, fading etc. will be of much value to our engineers in determining coverage and antenna radiation.

Perhaps you would now like to hear something about Greymouth. It has a population of approximately 9 thousand, is the province's principal town and is situated $\frac{1}{3}$ of the way down the West Coast of the South Island of New Zealand. The famous Franz Josef and Fox glaciers which are eight and nine miles long respectively, also our highest peak Mount Cook (12,349 ft.) - the maori name is Aorangi meaning "cloud piercer" - are approximately 94 geographical miles south by great circle bearing. The road distance is 132. An interesting point about our long steep glaciers is that their terminal faces are only a few hundred feet above sea level and 11 miles from the coast.

This is an industrial area the chief occupations being coal mining, timber milling, gold dredging and farming. The largest gold dredge in the southern hemisphere is working full-time at Kaniere, two miles east of Hokitika and twenty-seven miles south of Greymouth.

It is with much pleasure that I reciprocate best wishes and congratulations from the thirty members of my staff and I should like to send warm greetings to the U.S.A. from New Zealand. We are indebted to your great country for the assistance given us during the last global conflict. I hope we shall be for ever mindful of America's services and protection.

Do write and let us know if you are again successful in logging our programmes.

Thank you very much for your detailed report of reception of this Station 2ZA on April 26th., 1951. As this is the first report we have received from U.S.A. on our new 2000 watt Transmitter, it was more than welcome. Our Studios are located in the centre of Palmerston North City, (population 30000) and the Transmitter is three miles distant, being remotely controlled and unattended. We visit and service it twice weekly, but actually very little servicing is required. The Transmitter is manufactured by Amalgamated Wireless of Australia and is very accessible, being similiar to the Collins 1KW rig. Our transmitting schedule is as follows;
