Dear Mr. Geary;

We wish to thank you very kindly for your complete and detailed report on reception of our D.X. broadcast.

The details of your report leave no doubt that it was C.J.N.B. which you logged, and we are pleased that we were heard so distinctly at Walnutport.

Accordingly, we are happy to send you this Letter of Verification of reception of our signals.

Your report has been easily the most complete-from a technical angle. We especially appreciate your remarks on the quality of our signal and the efficiency of our transmission set-up.

You will be interested to know that we use predominantly Northern (Western) Electric equipment, and that our 250 watt transmitter (grid-modulated in the final stage) is loaded into an off-centre fed T-type, current fed through a capacitor. The steel situation made it impossible for us to get a steel tower, and now that we have plans for higher wattage- we are deferring the tower for our new installation. It is gratifying that our poor old T-type is performing so well. Our staff numbers fourteen, including myself and two transmitter op's. plus an announcer-engineer (a technical department of four).
